- 1. The LGU-Cabanatuan City, through the General Fund FY 2021 intends to apply the sum of Four Million Seven Hundred Twenty-Seven Thousand Two Hundred Seventy-Five Pesos and 99/100 (P4,727,275.99) being the Approved Budget for the Contract (ABC) to payments under the contract for the Furnishing of Labor and Materials for the Construction of Double Barrel Box Culvert @ Brgy. Cruz Roja, Cabanatuan City. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above-mentioned project. Completion of the Works must be accomplished within Eighty-Seven (87) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
