Description

INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF LABORATORY SUPPLIES ITB No.2022-09-PB-GOODS-0056

- 1. The LGU-Cabanatuan City, through the General Fund FY 2022 Intends to apply the sum of One Million Five Hundred Fourteen Thousand Two Hundred Thirty Pesos and 65/100 (₱ 1,514,230.65) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Laboratory Supplies. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Ninety (90) Days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective bidders may obtain further information from LGU-Cabanatuan City and inspect the Bidding Documents at the address given below during 9:00am to 12:00noon and 1:00pm to 4:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 05 September 2022 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (\$\mathbf{P}\$ 5,000). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The LGU-Cabanatuan City will hold a Pre-Bid Conference1 on 13 September 2022 at 2:00 pm at Conference Room, City Mayor's Office, City Hall Didg., Kapt. Pepe Subd., Cabanatuan City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretoriat at the address below on or before 27 September 2022 at 11:00 am. Late bids shall not be accepted.

- θ . All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause \Re .
- 9. Bid opening shall be on 27 September 2022 at 11:00 am at Conference Room, City Mayor's Office, City Hall Bidg., Kapt. Pape Subd., Cobanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

The LGU-Cabanatuan City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 34.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
