BAC Resolution Negotiated Procurement as Alternative Mode of Procurement and Recommending Approval

WHEREAS, the LGU-City of Cabanatuan, is purchasing **Postage Stamps**.

WHEREAS, **PHILIPPINE POSTAL CORPORATION** submitted a price quotation for the said supplies.

WHEREAS, based on Section 10 of the Revised Implementing Rules and Regulations of Republic Act 9184 and its Implementing Rules and Regulations Part A (IRR-A) it provides that:

Section 53(c). Negotiated Procurement

All procurement shall be done through open and competitive bidding. Only in highly exceptional cases, and when justified by the conditions prescribed under these guidelines, can the procuring entity procure from another government agency (hereinafter, referred to as *Agency-to-Agency Agreements*). Agency-to-Agency Agreements may only be resorted to if the following conditions are complied with:

- i) Conduct of a Cost-benefit Analysis by the Procuring Agency indicating that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical for the government.
