BAC Resolution Declaring Direct Contracting as Alternative Mode of Procurement and Recommending Approval

WHEREAS, the LGU-City of Cabanatuan, is Purchasing **Repair and Maintenance of Motor Vehicle used for Disaster Operations and Emergency Response**

WHEREAS, a survey had been conducted by the Supply and Property Management Division of General Services Office regarding **Repair and Maintenance of Motor Vehicle** and in the process no dealer offering lower prices nor substitute/alternative dealer offering terms are beneficial or advantageous to the City Government was identified.

WHEREAS, **ROYCE MOTOR CENTER, INC.** submitted a price quotation for the said **Repair and Maintenance of Motor Vehicle used for Disaster Operations and Emergency Response**

WHEREAS, based on Section 50 of the Revised Implementing Rules and Regulations of Republic Act 9184 it provides that:

Section 50. Direct Contracting

Direct Contracting or single source procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:

- c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP.
