Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 9. Bid opening shall be on 01 August 2023 at 9:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
