## Description

INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF RICE ITB No.2023-08-PB-GOODS-0050

- 1. The LGU-Cabanatuan City, through the Trust Fund FY 2023 intends to apply the sum of Forty Million Thirty-Nine Thousand Nine Hundred Twenty Pesos (P 40,039,920.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Rice. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Forty-Five (45) Days.
