- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 05 September 2023 at 10:00 am. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.



- 9. Bid opening shall be on 05 September 2023 at 10:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
