- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Thirty (30) Days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184. The Procuring Entity shall allow the bidder to present its proof of payment for the fees,

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 19 September 2023 at 10:00 am. Late bids shall not be accepted.



- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 19 September 2023 at 10:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
