The LGU-Cabanatuan City, through the Special Education Fund FY 2023 intends to apply the sum of Sixty-Five Million Two Hundred Thirty-Three Thousand Two Hundred Ninety-Five Pesos and 50/100 (P 65,233,295.50) being the Approved Budget for the Contract (ABC) to payments under the contract for the Furnishing of Labor and Materials for the Proposed Four (4) Storey School Building @ J.P.
