REQUEST FOR EXPRESSION OF INTEREST FOR

- 1. The City Government of Cabanatuan, through the General Fund (Calamity Fund) F.Y. 2023, intends to apply the sum of Fourteen Million Pesos (P 14,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Consultancy Services for the Review, Updating and Completion of the Comprehensive Land Use Plan, Zoning Ordinance, Comprehensive Development Plan, and Local Development Investment Program of Cabanatuan City, Bids received in excess of the ABC shall be automatically rejected at bid opening,
- 2. The City Government of Cabanatuan, now calls for the submission of eligibility documents for Consultancy Services for the Review, Updating and Completion of the Comprehensive Land Use Plan, Zoning Ordinance, Comprehensive Development Plan, and Local Development Investment Program of Cabanatuan City. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before 03 November 2023 at BAC Office, 2nd Floor, City Government Building, Phase II, Kapt. Pepe Subd., Cabanatuan City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 3. Interested bidders may obtain further information from Bids and Awards Committee of the City Government of Cabanatuan, and Inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders on 27 October 2023 from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P25,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.



5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are: Criteria Point System

1. Experience and Qualifications of Key Personnel

2. Experience and Capability of the Firm 40%

Experience and of the firm in handling urban and regional planning, master planning, or tourism planning More than

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

- 6. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 7. The Procuring Entity shall evaluate bids using the Quality-Based Evaluation/Selection (QBE) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 8. The contract shall be completed within Three Hundred (300) days.
- 9. The City Government of Cabanatuan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
