The LGU-Cabanatuan City, through the General Fund FY 2023 intends to apply the sum of Seven Million One Hundred Eighty Thousand Pesos (P 7,180,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Tires and Batteries. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Forty-Five (45) Days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
