- 1. The LGU-Cabanatuan City, through the General Fund FY 2023 intends to apply the sum of Two Million Nine Hundred Thirty-Two Thousand Two Hundred Ten Pesos (P 2,932,210.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Fuel and Lubricants for Desilting, Declogging, Dredging, Clearing of Sapang-Patalac Creek. - A complete set of Bidding Documents may be acquired by interested Bidders on 14 November 2023 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14
- 9. Bid opening shall be on 05 December 2023 at 11:00 am at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

The LGU-Cabanatuan City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 34.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
