Description

INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF OFFICE SUPPLIES I.B. No.2023-11-PB-GOODS-0094

- 1. The LGU-Cabanatuan City, through the General Fund FY 2023 intends to apply the sum of Two Million Three Hundred Thirty-Seven Thousand Eight Hundred Seventy-One Pesos and 37/100 (₱ 2,337,871.37) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Office Supplies. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LGU-Cabanatuan City now invites bids for the above Procurement Project. Delivery of the Goods is required by Thirty (30) Days. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No.
- 4. Prospective bidders may obtain further information from LGU-Cabanatuan City and inspect the Bidding Documents at the address given below during 9:00am to 12:00noon and 1:00pm to 4:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 14 November 2023 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The LGU-Cabanatuan City will hold a Pre-Bid Conference1 on 22 November 2023 at 3:00 pm at Conference Room, City Mayor's Office, City Hall Bidg., Kapt. Pepe Subd., Cabanatuan City which shall be open to prospective bidders.



- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 05 December 2023 at 3:00 pm. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 05 December 2023 at 3:00 pm at Conference Room, City Mayor's Office, City Hall Bldg., Kapt. Pepe Subd., Cabanatuan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10. The LGU-Cabanatuan City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 34.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
